WHAT

The Carl A. Nelson Charitable Foundation (the Foundation) was established in 2004. The Foundation is a nonprofit, tax-exempt entity that is governed by a Board of Directors currently consisting of five members. The Board members are; Tim Seibert, who has been on the Board since 2004, Chris Smith who joined the Board in 2007, Christine Robertson who joined in 2011, Charlie Carlson, a retired employee of Carl A. Nelson & Company, who joined the board in 2017, and James Maletta who also joined the Board in 2017.

the what the why and the how

WHY

With the existence of the Foundation, Carl A. Nelson & Company and its employees are able to work together to fund charitable activities. Because the Foundation is a tax-exempt entity and contributions received by the foundation are tax deductible to those who are making the contribution, the funds received by the Foundation can go a lot further in helping support the charitable endeavors of the Foundation.

Providing support for employees in times of need was the motivation for the formation of the Foundation. As a result, the purpose of the foundation includes assisting fellow employees and their families in medical, emotional and physical distress created by extreme financial burden due to an illness or natural disaster. In addition, the Foundation provides scholarships and supports other similar-minded charities in the area.

HOW

The Foundation would not exist without contributions from employees, retirees, and Carl A. Nelson & Company. When aggregated all of the dollars that are contributed add up quickly. Since inception, the Foundation has received over \$320,000 in contributions, which includes close to \$88,000 from current and former employees.

We encourage Carl A. Nelson & Company employees to make a weekly payroll contribution to the Foundation. A statement of your tax-deductible contributions will be provided to you after the end of the year. A contribution form is attached to the newsletter for your convenience. Just fill out the form and return it to the office in Burlington if you would like to make a one-time contribution, start making weekly contributions to the Foundation through a payroll deduction, or if you would like to increase your current contribution. Keep in mind that you can contribute as little as \$1.00 per week. If you have any questions you can contact Renita Jarrett or Christine Robertson in Carl A. Nelson & Company's Burlington office and they would be happy to help you.

Supporting Education

There are two scholarships that the Foundation provides for dependents of employees, the Louis H. Kuepper Memorial Scholarship and the Timothy S. Ballard Scholarship. Both scholarships provide \$2,000 towards educational expenses for the student. Each spring the Foundation accepts applications for scholarships from any child of a Carl A. Nelson & Company employee who is continuing their education

beyond high school. Applications are generally due by the first part of April, so if you have a student who would qualify, please make sure to submit an application at that time.

A memo will be sent out in the spring to remind you and provide more information about the scholarships. Though prior recipients of the scholarships are not eligible, <u>keep in</u>



mind that your son or daughter may apply for the scholarships multiple times. If your student has applied for one of the scholarships in the past but was not awarded a scholarship, encourage them to apply again!

Colton Ketcham (son of Kathy Ketcham), pictured to the left, is the recipient of the Louis H. Kuepper Memorial Scholarship this year. Colton graduated from Danville High School in May. While in high school, Colton was Student Body President, a State Student Council Officer, captain of both the swimming and golf teams, earned his Eagle Scout rank and was awarded an international internship that was sponsored by the World Food Prize. The international internship gave Colton the opportunity to travel to Kenya this past summer to be involved in a research project. Colton is currently attending the University of Iowa to study Bio-medical Engineering.

In addition to the Louis H. Kuepper Memorial Scholarship and the Timothy S. Ballard Scholarship, the Foundation provides another scholarship, the Carl A. Nelson Scholarship. This scholarship is for \$1,000 and is provided to a second-year Construction Technology student at Southeastern Community College (SCC). For 2018, the recipient of the Carl A. Nelson Scholarship was selected by an SCC Construction Technology

instructor who is familiar with the students' performance in class.

The instructor actually contacted us and requested that we split the scholarship in half because there were two very deserving students. Instead of splitting the scholarship into two \$500 scholarships, the Foundation's Board of Directors voted to provide a second \$1,000 scholarship. Therefore, this year Remington Benz, pictured to the right, and Broc Mullin (not pictured) both were awarded a Carl A. Nelson Scholarship for the 2018-2019 school year.

Remington graduated from Mediapolis High School. He said that he has always wanted to work with his hands and would eventually like to own his own construction company. Remington enjoys boating, waterfowl hunting and watching the Cubs and Forty-Niners play.

Supporting Others

Through the Foundation, Carl A. Nelson & Company and its employees, past and present, have provided over \$50,000 of support for other employees who have fallen on hard times due to an illness. If you know of a fellow employee who has a need due to illness or natural disaster, encourage them to contact one of the Board members to request an application. All applications must be submitted by the individual requesting assistance. Requests for individual assistance are evaluated by the Board as soon as possible after they are received. Because the Foundation is a tax-exempt entity, the Foundation can only provide relief to individuals with an extreme financial need due to illness or natural disaster.

In addition to supporting employees, the Foundation can and does support other organizations that are tax exempt entities providing relief to certain individuals and promoting social welfare. Distributions from the Foundation are made on an annual basis to contribute to many like-minded civic organizations supporting the surrounding communities.

You are encouraged to notify the Foundation if there are organizations that you support, has supported you, or you otherwise feel the Foundation's Board should consider when making decisions about contributions. You can notify the Foundation at any time throughout the year. Generally, the Board meets in early September to review all of the requests.

Over the years, distributions to other organizations and civic projects from the Foundation have totaled almost \$155,000. The chart below shows how those funds have been distributed among various organizations:



Contributions were made this year for the first time to the Alzheimer's Association and Hair, Hats & More. Hair, Hats & More is a program that provides wigs, scarves, hats, etc., to Great River Cancer Center patients who are losing their hair. In addition to those organizations receiving first-time contributions, the following organizations are also receiving contributions this year from the Foundation:

Carl A. Nelson & Company and its employees have always prided themselves with their willingness to help others through many different civic-minded channels. Contributing time and resources to the United Way, Junior Achievement, Hope Haven, various schools and numerous other organizations. Assistance has also been provided to help fellow employees during an illness.

In 2004 the Carl A. Nelson Charitable Foundation (the Foundation) was established to provide relief, in our local communities, for individuals with medical, emotional, and physical distress created by unforeseen poverty or extreme financial burden due to illness or natural disaster. As this Foundation is qualified under the Internal Revenue Service guidelines as a 501(c)(3) organization, contributions are tax deductible so the dollars contributed can all be available for charitable purposes. A statement of tax-deductible contributions is provided after the end of the year to those who make a contribution to the Foundation.

The Foundation Board is comprised of three officers of Carl A. Nelson & Company (Tim Seibert, Christine Robertson, and Chris Smith), one other current Carl A. Nelson & Company employee (James Maletta), plus one outside member (Charlie Carlson, a Carl A. Nelson & Company retiree). Requests for assistance will be reviewed by the Board on a nondiscriminatory basis, applying limited funds where the greatest social good can be accomplished.

Carl A. Nelson & Company employees may elect to contribute to the Foundation through payroll deduction on either a weekly or one-time basis or they can make a direct contribution. You may also specify how your funds are to be used by selecting any of the three funds: The Relief Fund for hardship assistance, The Scholarship Fund for educational expenses, or The General Fund which is distributed at the discretion of the Board.
